





### Clinton Global Initiative: Inspiring Change

President Bill Clinton and the William J. Clinton Foundation have launched the Clinton Global Initiative to help our world move beyond the current state of globalization to a more integrated global community of shared benefits, responsibilities, and values.

The mission of the William J. Clinton Foundation, and the goal of this Initiative, is to increase the benefits and reduce the burdens of global interdependence; to make a world of more partners and fewer enemies; and to give more people the tools they need to build a better future.

The Clinton Global Initiative is a non-partisan endeavor, bringing together a carefully selected group of the world's best minds and most distinguished problem solvers to focus on practical, effective measures that can be taken now. These leaders—from a wide variety of political, ideological, religious, ethnic, and geographic backgrounds—include current and former heads of state, top business executives, preeminent scholars, and representatives of key non-governmental organizations. The Clinton Global Initiative will be held in New York City, September 15-17, 2005, coinciding with and complementing the Millennium Summit of the U.N. General Assembly.

This Initiative is unlike other world conferences in one respect: it is determined to change things now, by discussing some of the world's most pressing problems; detailing successful responses to them; seeking the best new solutions; and most important, obtaining a specific commitment from each participant to take action in one of the topics discussed.

# Clinton Global Initiative is About Finding Solutions



### SEPTEMBER 15-17, 2005 • NEW YORK CITY

As President Clinton said in his first inaugural address, "Our greatest strength is the power of our ideas." By bringing together a select group of the world's most innovative and accomplished leaders for a series of workshops this September 15-17, 2005, in New York City, the Clinton Global Initiative will provide discussion and debate on four of our most pressing global challenges:

- The Escape from Poverty: Forging a Partnership Between the Developed and Developing World
- Religion, Conflict and Reconciliation in the 21st Century
- Climate Change: Business Challenge, Business Opportunity
- Enhancing Governance: Building Capacity, Transparency, and Integrity

Prior to the September meeting in New York City, participants will receive workshop briefing materials to review. This pre-meeting assignment will ensure that everyone arrives prepared to play an active and engaged role in the results-oriented discussions.

Guided by expert panelists, each workshop will focus on what has worked successfully in the past and how these proven strategies can be adapted for post-conference action. The goal is to identify and apply practical, non-partisan responses to the issues addressed in each workshop, and to encourage and assist all participants in undertaking specific follow-up actions in at least one of the topic areas.



### THE ESCAPE FROM POVERTY:

FORGING A PARTNERSHIP BETWEEN THE DEVELOPED AND DEVELOPING WORLD

Despite the immense accumulation of wealth and reduction in poverty generated by globalization, one half of the world's population still lives on less than \$2 a day, and more than a billion people go to bed hungry every night.



Every year, six million children die of malnutrition—that is one child every 3.6 seconds. Yet most experts agree that extreme poverty can be eliminated within a decade with an investment of just one half of one percent of the incomes of the developed countries.


Targeted debt relief and the elimination of government subsidies and trade barriers can have an enormously beneficial impact on poverty reduction. Global corporations also are beginning to engage in poverty reduction in exciting new ways by creating innovative financial products and services tailored to the poor. Extreme poverty can be eradicated, and everyone has a crucial role to play—from world leaders upholding aid commitments and negotiating fair trade agreements to corporations launching microfinance initiatives to NGOs and private donors ensuring that aid is used effectively.

More than 80% of the world's population identify themselves as religious. However, longstanding and bitter rivalries have often obscured the shared principles, values, and beliefs inherent in the world's major religions, and religion has often been used to justify oppression and war. Too frequently, Islam's relationship to Christianity and the West has been marked less by understanding than by mutual ignorance and conflict. The challenge is to recognize not only our differences but also our common interests. Suffering and poverty are deep concerns of virtually every faith, as the overwhelming response to the recent tsunami has demonstrated.

In recent years, with the focus on links between civil society and development, religious organizations have been acknowledged for their leadership role. Frequently, for the world's most vulnerable populations, faith-based organizations are the largest provider of services and support, including education, community development, and HIV/AIDS care, although in some cases, religious organizations impede these very efforts. Because many conflicts derive from differences in faith, religious leaders must be part of any effort at conflict resolution and prevention.

# RELIGION, CONFLICT, AND RECONCILIATION IN THE 21ST CENTURY

Throughout history, we naturally identify with what we know and understand—our family, our tribe, our nation, our race, our religion—and define ourselves by negative references to "others." But, as we have become more interdependent, we are compelled to expand the definition of who is "us" and shrink the definition of who is "them."



We need a more pragmatic and honest discussion about the specific ways in which religion can inspire, rather than impede, dialogue, understanding, and reconciliation.

## CLIMATE CHANGE: BUSINESS CHALLENGE, BUSINESS OPPORTUNITY

Pollution knows no boundaries. A smokestack in one part of the world may contribute directly to the destabilization of the climate in another part. Without a healthy and stable environment, sustainable economic and social development is impossible.



Since the late 1800s, industrialization has caused the average temperature of the Earth's surface to rise by 0.8 degrees Celsius. Left unchecked, the byproducts of human activity could raise global temperatures an additional 5.8 degrees Celsius by century's end. is alarming trend is expected to cause severe storms, floods, and droughts. Numerous plant and animal species, already weakened by pollution and loss of habitat, are not expected to survive the next 100 years. Without a healthy and stable environment, sustainable economic and social development is impossible. This is particularly clear in developing countries where many

people rely on nature for everything from food and medicine to energy and water supplies.

As the threat posed by global warming becomes more pronounced, companies and governments have started to turn their attention to solutions. Emissions trading programs that cap the total output of carbon dioxide emissions allow businesses to buy and sell—"trade"—emission allowances; analysts predict that the size of the global carbon market could be as much as \$1 trillion by 2010. The United States used an emission trading program to reduce acid rain pollution. It proved to be cheaper than traditional environmental regulations and led to an unprecedented level of compliance in the private sector.

We need to explore other innovative options as well, such as targeted tax incentives to stimulate the research and development of clean energy technology. Agricultural subsidies could be reallocated from food crops to biofuels, which will not only enhance global climate security but also each nation's energy security. Existing clean energy technologies and fuels—biomass, hydrogen, electricity, wind and solar—could be more widely deployed. The old energy economy is well organized, well financed, and politically influential. The new energy economy is entrepreneurial and decentralized, undercapitalized, and without substantial political power, yet the economic potential is enormous. We must do more to tap it.

For the first time in history, most people live under freely elected governments. That translates into greater cooperation in international trade, protection of human rights and the fight against terror. Respect for the rule of law must be a vital component of a united vision of a better world.

Even in cases where newly democratic governments recognize the value of good governance, they often lack the capacity to implement it. Studies have shown that wealthier countries have less reported corruption and better functioning governments than poorer countries. Policy initiatives—whether designed to defeat terrorism, improve education, healthcare and the environment, or alleviate poverty—will be less likely to succeed in poorer countries with weak governance structures vulnerable to corruption. Introducing greater transparency and accountability and promoting the eradication of corrupt practices at all levels of government are also essential for attracting increased foreign direct investment. Before equitable economic growth can be achieved, capacity must be developed so that effective governance mechanisms are firmly in place. Ample foreign aid will be needed to bolster their ongoing capacity-building efforts and institutional reform.

In many countries, illegal payments to ensure the introduction of particular rules and regulations, or the

avoidance of existing ones, are common. The key is to find a way to eliminate outdated laws and regulations and keep those necessary to control pollution and protecting worker health and safety; to ensure that they are administered in ways that minimize corruption; and to increase administrative capacity in developing nations. A major obstacle to strengthening governance is the difficulty of overcoming entrenched interests; however, the good news is that many countries have placed good governance at the forefront of their agendas.


The Foundation works principally through partnerships with like-minded individuals, organizations, corporations, and governments, often serving as an incubator for new policies and programs.
