4. Italy – Policy priorities

I will first invite Mario Monti to present the policy priorities of the Italian government. Then I will invite Olli Rehn and Mario Draghi to present their views. Thereafter, I will invite Vittorio Grilli to report on the EWG discussions and the IMF to report on its monitoring activities, before opening the floor to you for questions and comments.

5. Stability in the euro area – EFSF leveraging and financial stability developments in the euro area

The guidelines on leveraging instruments for the EFSF should be endorsed. I also suggest discussing financial stability developments in the euro area.

I will first ask Klaus Regling to present the guidelines. I will then invite Olli Rehn and Mario Draghi to present their views. Thereafter, I will ask Vittorio Grilli to report on the discussions in the Task Force for coordinated action and the EWG, before opening the floor to you for comments and questions.

6. Euro area governance – Commission proposals and preparation of December Euro summit

I suggest discussing the Commission proposals for regulations strengthening euro area governance published on 23 November. I also suggest debriefing the Eurogroup on the ongoing work on the report to the December European Council, including the possibilities of limited Treaty changes.

I will first invite Olli Rehn to present the Commission proposals. Then I will ask Mario Draghi to present his views. Thereafter, I will debrief you on the report to the European Council, before opening the floor to you for comments and questions.
