The aim is to stimulate and inform discussion of the distinctive features of voluntary sector organisation and management not only by academics and researchers but also by those who work in and with voluntary agencies and NGOs.

Copies of working papers are still available. Many of the titles have been subsequently been published elsewhere and are not therefore being reprinted. The titles being maintained by the Centre are listed here.

- **Voluntary Sector Case Studies** - edited versions of research-based dissertations produced by students on the MSc course in Voluntary Sector Organisation which have been selected for their relevance to those concerned with the organisation and management of voluntary agencies and NGOs.
