

Conclusions of the 2nd Spinelli-Group Steering Committee 12 December 2011

1. On Wednesday 12 January, the Spinelli Group held a public debate in the European Parliament, attracting over 500 people and well over 1000 viewers on web-streaming. Chaired by Daniel Cohn-Bendit the debate featured a discussion between Joschka Fischer and Jean-Marc Ferry (both founding members of the Spinelli Group) on "the United States of Europe – towards a transnational society?".

It was followed by a meeting of the Steering Committee, which discussed i.) the Spinelli doctrine/Spinelli-stamp principles and ii.) the organisation of the 1st Shadow Council. Additional documents were distributed on the future of European finances, on the MEP-Spinelli Group and the Spinelli-Group's relations with think-tanks and established networks.

2. The discussion on the Spinelli doctrine was an opportunity to reflect on the means and objectives of the Spinelli-Group. Whereas all the members share the urgency and necessity of rekindling the European flame, there were some differences as to the definition of what "federalist" and "more Europe" meant both in principle and in practice. It was decided:

-to design a "Spinelli stamp", following the amended proposition of a "Spinelli doctrine" (see enc.) and to publish its guiding principles;

-to use the "Spinelli stamp" as well to "name and shame" a proposal/individual whose contribution to the European debate is deemed "regressive" or contrary to the community spirit;

-to invite institutions and/or proposals to seek the "Spinelli stamp" approval.

A trial of one year has also been decided, to assess the viability of the doctrine and the stamp, before its possible revision.

3. The Shadow Council will be organised on Tuesday 22 March, i.e. two days before the official Council, in order maximise media attention.

It should provide conclusions on 2 items – one taken from the agenda of the official Council and one advocated by the Spinelli-Group itself.

For this occasion, the two items should be: 1. economic governance/treaty changes and 2. the Union's own resources.

Documents will be circulated in advance for comments and revision.

The question of the timing of the Shadow Council was raised,. If it is too close to the European Council we can only expect to influence the fixed agenda, and probably only marginally. If we intend to influence the agenda of the Council, and/or the very substance of its outcome, the Shadow Council may need take place a week beforehand.

4. The next meeting of the Steering Committee will take place on 22 March in Brussels.
