ACTION COMMITTEE FOR EUROPEAN DEMOCRACY (ACED) MINUTES OF THE CONCLUSIONS 3RD MEETING, BERLIN 23/24 FEBRUARY 2007

I PARTICIPANTS¹

II COURSE OF ACTION OF REUNION

- Friday evening, working dinner in the hotel *Brandenburger Hof*: the ACED welcomed the German Minister of interior, Wolfgang Schäuble, as their guest. The session focused on questions of a suitable timetable for the ACED and the format of an alternative treaty to be suggested.
- Saturday morning, session in the Bosch Foundation: continuation of the discussion.
- Saturday lunch, Embassy of the Republic of Italy: closing of the meeting.

III KEY CONCLUSIONS

Of central importance will be a clear mandate to be produced under German presidency, estimating that only if backed by such a mandate the subsequent Portuguese and Slovenian presidencies will be able to engage with great commitment in the process to conclude it before the 2009 European parliamentary elections.

The group recognises that its proposals should not be published too early, an appropriate date should be between the French Presidential elections and the IGC in June.

Shape and Content of an alternative Treaty:

- In the light of the meeting of the 20 (supporters of the existent Treaty for a Constitution) and with reference to the letter by J.-L. Dehaene and I. Mendez de Vigo provided to the ACED, which underlined the likelihood that the more re-writing/re-shuffling the more would the scope for an IGC to conclude an agreement decrease,
- instead of a re-shuffling of the Constitutional Treaty (first intended to render text more acceptable to public opinion), it is preferable to stick closer to the existing structure and to work in the direction of a mandate produced under German presidency based upon the principles of:

 \rightarrow a shorter text including only on Parts I and II (through one article giving legal force to the Charter) and the absolutely necessary elements of Parts III and IV of the Constitutional Treaty, adding some new elements (e.g. on policies such as social, sustainable development, climate change, but also on institutions, such as the parliamentary election of the Commission's President),

 \rightarrow adapting the existing Treaties where necessary, without consolidating them into an entirely new text,

 \rightarrow there were discussions on the way of drafting the protocols:

• A 'traditional' option in which only changes are listed (e.g. in Article X, paragraph y the following words are added ...), and which might be shorter than Part III but only legible for experts;

o A longer but more legible option in which the changed articles and paragraphs are listed in full.

Drafts for the shorter treaty and protocols shall be prepared by the RSCAS.

- Alternatively to the option of including a substantial 'plus' in the first mandate for an IGC, it was suggested to split the process, so that the German presidency would produce two mandates:
 - 1. Mandate for an IGC to produce an alternative mainly *institutional* treaty (including the essential institutional reforms + and the absolutely necessary elements of Parts III and IV), this would have to provide the legal basis to produce new policies
 - \rightarrow short IGC to put into action this mandate;
 - 2. Mandate for a Single Act to go beyond the institutional and legal adaptations and formulate new policies in their substance: energy, climate, social issues etc. in

 \rightarrow IGC to deal with this mandate with a broader time frame, as from 2008.

NAME FOR AN ALTERNATIVE TREATY:

- An alternative treaty should not be a constitution nor bear this name.
- The ACED shall refrain from suggesting a specific name.

IV FURTHER PROCEDURE/MEETINGS

The ACED has fixed a final meeting which shall be held on the basis on a set of preparatory documents to be produced by the Robert Schuman Centre of Advanced Studies (Florence) outlining different options as outlined above.

REACH AND AUDIENCE OF FINAL REPORT BY THE ACED:

- The final report should address the German and subsequent EU presidencies, and •
- the wider public, providing ideas in the broad direction of the 'federalist papers', ? as well as the ACED members should support campaigns - also beyond the limits of the
- meetings of the ACED targeting specific objections raised in the most 'critical' countries.

DATE AND VENUE FOR THE FINAL MEETING:

• Brussels 3/4 June 2007:

Meeting on Sunday evening to finalise the discussions to be followed by a press conference in the late Monday morning.

PREPARATION FOR FINAL DOCUMENT / OPTION FOR INTERMEDIATE MEETING

- The documents which have been called on to be written by the RSCAS will be distributed by the end of March 2007,
- comments on these are to be circulated via e-mail amongst the members of the ACED in order to estimate whether they provide a sufficient basis to agree on a final document in Brussels in June.
