The ECB shall pay an amount of EUR 700 as remuneration for the performance including per diems. As the Contractor is not resident/established in Germany but in another EU Member State, the Services provided to the ECB shall not be subject to VAT on the basis of Article 15(10) of council Directive 77/388/EEC. On request, the ECB shall provide the Contractor with the appropriate certificate.

Upon completion of the performance, please submit to the ECB an invoice which shows the day and hours of the performance and quotes code C-305900-4040. Any invoice shall be sent to:

The ECB shall pay such invoice within 10 working days after the date of the receipt thereof.

In addition, the ECB shall arrange and cover the costs for travel and accommodation as follows:

- Flight Athens-Frankfurt-Athens, economy class, from 25 to 27 October 2007 for one person
- Standard hotel room accommodation (1 double room) for the nights of 25 and 26 October 2007
- Local transfers in Frankfurt am Main by taxi (receipts required with the invoice).

We would draw your attention to the fact that the ECB may, at any time, cancel the scheduled event. If the cancellation is notified to you less than 15 working days before the scheduled date, the ECB shall pay 40% of the remuneration. The ECB shall not pay for any cancellation due to *force majeure*.

We ask you to provide the ECB, free of charge, with information about Nikos Themelis and the performance, in particular photos, texts, press notes and other necessary information. The ECB shall use such information for public relations purposes in the context of the Cultural Days of the European Central Bank - Greece 2007, in particular to issue promotional material for the performance.


